- 1. Visit immigration system at *immi.gov.bt*. If you are a first-time user, you need to register.
- 2. Ensure you have a valid email address.
- 3. Please ensure the following documents are ready:
 - (i) Approval from the relevant agency.
 - (ii) Form DOCMC2025 (This form).
- Submit immigration card application through immi.gov.bt. Please select the nearest immigration office.

Notification

After submission, the assessment outcome including actions required will be communicated through the registered email.

Payment of fees

The payment can be made online using the link shared through the registered email.

General conditions of compliance

By signing this form, you acknowledge that you have read and understood the terms and conditions outlined herein and voluntarily agree to ensure compliance with the following terms and conditions:

- (i) Complete immigration card formalities as per immigration rules.
- (ii) Comply with immigration formalities during entry, stay and travel within the country, and during exit.
- (iii) Comply with general health screening including drug tests, as may be applicable.
- (iv) Not seek employment or work in any organization in the Kingdom without prior approval from the Department of Immigration.
- (v) Not operate or apply for operation of business in the country.
- (vi) Register the child with the Department of Immigration within one year of the child's birth.
- (vii) Renew the immigration card at-least 14 days before the expiry of the permit. Failure to renew the immigration card on time is regarded as an overstay and could lead to fines and penalties including deportation and denial of entry, or prosecutions, as may be applicable.
