4. Submit immigration card renewal application through [immi.gov.bt](http://immi.gov.bt). Please select the nearest immigration office.

- (ii) Not seek employment or work in any organization in the Kingdom without prior approval from the Department of Immigration.
- (iii) Not operate or apply for operation of business in the country.
- (iv) Complete the immigration card renewal formalities in accordance with immigration rules, ensuring renewal at least 14 days prior to the expiry of the permit. Failure to do so shall be considered an overstay and may result in fines, penalties, deportation, denial of entry, or prosecution, as applicable.
- (v) Comply with immigration formalities during entry, stay, and travel within the country, and during exit.
- (vi) If you have a child, register the child with the Department of Immigration within one year of the child's birth. For registering the child, please visit [immi.gov.bt](http://immi.gov.bt) (child registration).
