1. Visit immigration system at immi.gov.bt. If you are a first-time user, you need to register.
2. Ensure you have a valid email address.
3. Please ensure the following documents are ready:
 - (i) Approval from the relevant agency.
 - (ii) Form DOCE2025.
4. Submit work permit application through immi.gov.bt. Please select the immigration office as per the zonation system.

Notification

After submission, the assessment outcome including actions required will be communicated through the registered email.

The payment can be made online using the link shared through the registered email.

- (vi) Ensure compliance with exit requirements and age ceiling and exit the country as stipulated in the immigration rule.
- (vii) Renew the work permit at-least 14 days before the expiry of the permit. Failure to renew the work permit on time is regarded as an overstay and could lead to fines and penalties including deportation and denial of entry of the foreign worker, or denial of service or prosecutions, as may be applicable.
