



TRANSIT VISA APPLICATION FORM

IMPORTANT INFORMATION – Please read this information carefully before you complete your application. After completing the application, we highly recommend that you keep a copy for your record.

All relevant questions on this form should be answered. Please submit all additional information/documents if requested.

The Department of Immigration (DoI) will communicate the outcome of the application within three working days from the receipt of the required documents and applicable fees.

Who should use this form?

All foreigners passing through Bhutan en route to a third country where entry into Bhutan is required for airport layovers, connecting flights, or land transit.

General conditions

1. The traveler must carry the valid passport against which the transit visa has been issued. The passport shall be valid for at least six months from the intended date of arrival into the Kingdom.
2. The traveler must also possess a valid visa or entry authorization for the final destination country.
3. A transit visa shall be issued only for 48 hours in line with the Immigration Act of the Kingdom of Bhutan.
4. The traveler must comply with the transit time limits and movement restrictions within the transit area.
5. The traveler must be in immediate and continuous transit to the destination country.
6. The designated port of entry for transit shall be international airports in Bhutan.
7. Foreigners with transit visas are not authorized to undertake tourism, employment, or any other activity within Bhutan.
8. The visa application fee is non-refundable and non-transferable.

How to apply online

1. Visit immigration system at <https://immi.gov.bt>. If you are a first-time user, you need to register.
2. Ensure you have a valid email address.
3. Please ensure the following documents are ready:
 - a) Form TRANSITVISA2026
 - b) Copy of passport
 - c) Digital photograph
 - d) Valid visa/entry authorization for next destination country
4. Submit visa application through <https://immi.gov.bt>
