In the Department's continued effort to enhance transparency and improve communication, we are thrilled to launch this new monthly update. This bulletin aims to keep the public, agencies, stakeholders and visitors informed about our ongoing transformation, policy updates, key immigration data, trends and operational highlights.

### Key Highlights and Transformation Updates (February-April 2026)

Keeping you informed of regulatory changes is our top priority. As we launch this bulletin, please take note of our most recent policy updates:

**Automated Immigration Clearance System:** Biometrics e-gates are now operational at Pedestrian Terminal, Phuentsholing and Paro International Airport, reducing clearance times and enhancing security.

**Launch of Stamp-less Visa Services:** Effective February 27, 2026, the DoI has introduced Stamp-less Visa Regime. Applicants availing visa services are no longer required to visit in person or produce their original passports at Immigration Offices enabling faster processing.

**Processing Efficiency:** Following recent digital transformation, the processing time at the port of entry has reduced from 60 seconds to 20 seconds per traveler.

**Digital Adoption:** Over 99% of all precleared visa applicants are processed through the eGates at the Paro International Airport, marking our highest digital compliance rate to date.

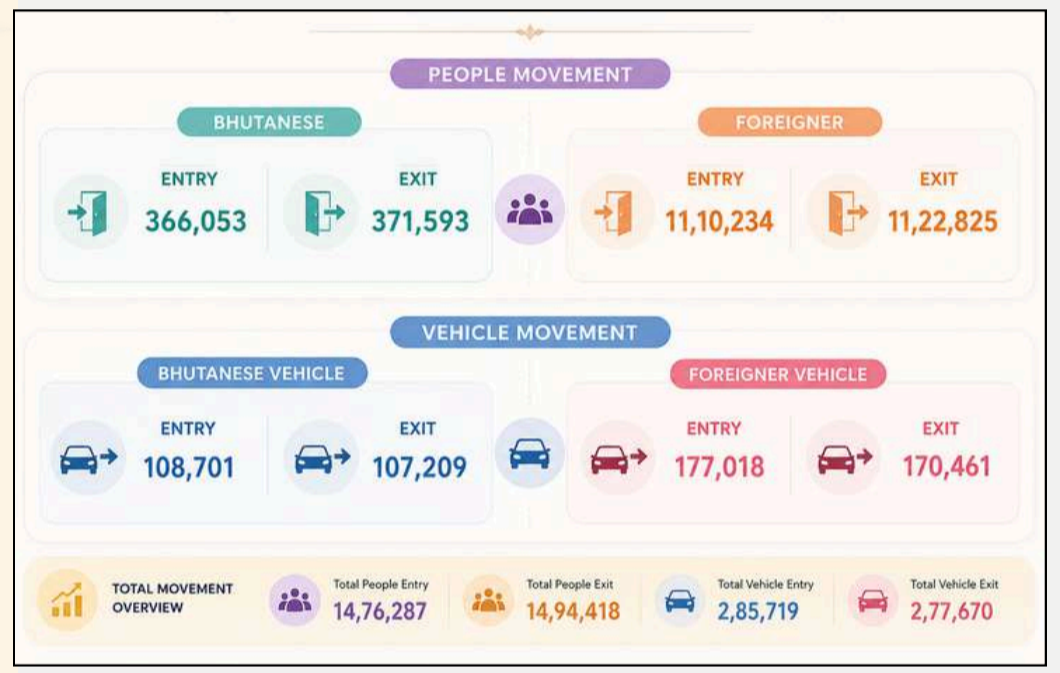
Here is a look at recent trend in immigration for April, 2026:

##### Work Permit



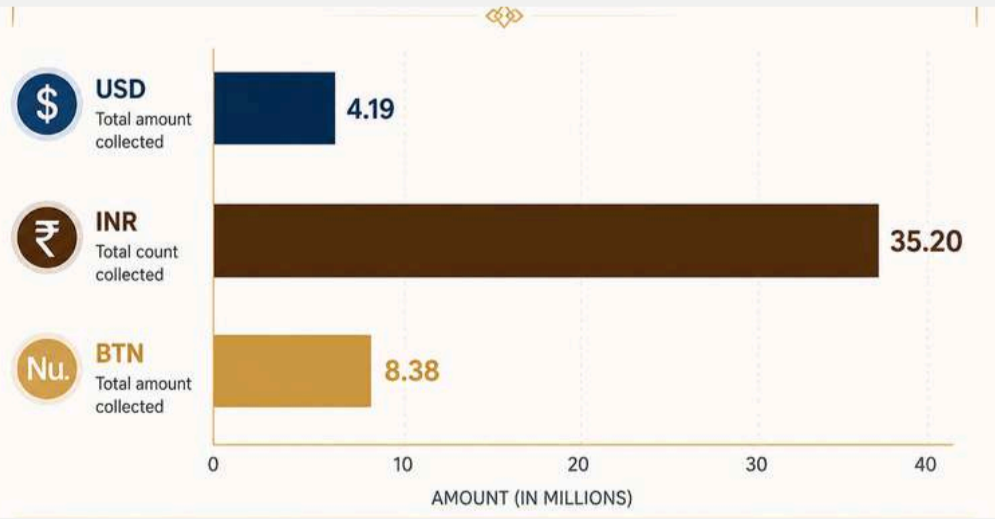
